Net metering allows homeowners that create excess energy to use it as a credit on their next electric bill. Net metering in Alabama is not mandated, but companies like Alabama power participate. None : Property Tax Exemption : The state of Alabama does not increase property taxes for those with a solar panel installation.

First Solar said its latest investment is expected to bring the company's total investment in U.S. manufacturing to over \$4 billion. In addition to the new Alabama facility, the company previously announced that it is investing \$185 million to upgrade and expand its Northwest Ohio manufacturing footprint by 0.9 GWdc.

The Public Service Commission and Alabama Power both declined comment, citing the ongoing litigation. Alabama ranks near the bottom in terms of renewable energy adoption, even when compared to other states with a similar demographic and political composition, but has incentives meant to encourage the adoption of solar energy.
