



# Bankrupt solar energy companies

The US residential-solar industry is under serious threat -- a vulnerability borne out this week by the bankruptcy of SunPower Corp., one of the sector's most venerable names. ...

So as long as the solar installer and manufacturer aren't the same company, you should still be able to call the manufacturer for warrantied service on the panels. If your installer is also the manufacturer of the solar panels, bankruptcy could affect your manufacturer warranty.

Titan Solar Power was under scrutiny for months after receiving complaints from customers in various states. October 14, 2021, saw bankruptcy petitions filed for South Carolina's SunStore Solar, LLC and Washington State's UniEnergy Technologies, LLC, while Texas' Let's Go Solar, LLC followed closely behind on October 15, 2021. Pennsylvania's Coatesville Solar Initiative, LLC filed its petition just a few days later on October 20, 2021.

Solar installer SunPower filed for bankruptcy on Aug. 5, becoming the latest solar company to succumb to the effects of rising costs, more competition and changing state incentives and regulations.

5 hours ago; In the world of solar energy, companies face challenges like any other industry. Oya Renewables, a solar energy producer with offices in Boston and Toronto, recently filed for Chapter 11 protection in the Delaware bankruptcy court. The company disclosed over \$100 million in liabilities, including nearly \$87 million in funded debt.

Not all companies survive Chapter 11 bankruptcies, though. Action you can take now: If your solar company files bankruptcy or another company acquires it, you should receive a letter in the mail telling you about the situation and if it will affect your contract.

Dozens of other solar firms have failed this year as well, including Infinity Energy, Solcius, and Kayo Energy. "We pretty much have a \$70,000 roof ornament at this point," says Jasmine Hendrickson, who had a system installed by Pink Energy a week before the company went out of business.
