The solar access laws in Washington DC are outlined in District of Columbia Code § 8-1774.51. This law limits the authority of homeowners associations, condominium owners associations, and cooperative housing associations to prohibit the installation and use of solar energy collection devices.

The Arizona HOA solar panel law, outlined in Arizona Revised Statute 33-1816, states that your HOA may establish reasonable guidelines for the placement of your solar panels but cannot outlaw them. These guidelines must not obstruct installation, impair device functionality, limit how the device can be used, or make it less effective or ...

RCW 64.38.055, commonly referred to as the Washington Solar Rights Law, prohibits HOAs from blocking solar panel installations that meet "applicable health and safety standards and requirements imposed by state ...

According to House Bill 362, which was signed into law in 2011, the law forbids HOAs from prohibiting solar energy installations unless several very specific ...

So, my HOA declaration states no solar panels. However, they were written in 1996 and have not been updated since. It was my understanding that in 2014 Virginia Senate Bill 222 removed the grandfathering clause allowing prohibition of solar panels.

Unfortunately, solar panels are still incredibly expensive for the average homeowner, even though they're more financially affordable now than ever. For solar panels to be viable, those seeking to install them need financing options and incentives. Without these, homeowners cannot pay the average \$16,000 cost of a moderate solar panel ...

For example, in Illinois, an HOA may restrict where you place your solar panels, but only if it doesn't reduce expected production by 10% or more. While an HOA may not have the authority to fully restrict the installation of solar panels, it may specify certain conditions or requirements such as:

Your HOA may deny your request to get solar panels installed in your home because they alter the look of your roof. Some states have enacted solar access laws that prohibit HOAs from denying your request to install solar panels.

While your HOA can't prohibit solar panel installation, it does have a voice in this matter. A review board or committee can determine the specific roof location on which the panels are to be installed as long as it is "within an orientation to the south or within 45° east or west of due south if such determination does not impair the ...
