Lithium ion batteries contained in equipment meeting the provisions of Section II of Packing Instruction 967 of the IATA Regulations. No more than four cells or two batteries may be mailed in any single package. Lithium battery mark labels are not required for packages that contain no more than four cells or two batteries contained in devices. UN3091

Mailing batteries internationally, or to and from APO, FPO, or DPO destinations, is prohibited regardless of mail class. See IMM 136 for details. a. General. The following restrictions apply ...

Visit the post office to send 2 batteries below 100 Wh installed in equipment. Don't attach any special labels or warnings to the box since you don't need them. ... Look online for a Lithium Battery Mark editor so you can add the information for your shipment. When you ship lithium ion batteries, use "UN3480" for single battery ...

Only lithium cells and batteries that are properly installed in the equipment they are intended to operate may be mailed internationally or to APO/FPO/DPO locations if the destination country and APO/FPO/DPO permit their receipt. For batteries either inside the device or sent separately in the packaging the Watt-hour rating must not exceed 20Wh per cell or 100Wh per lithium-ion /polymer battery. For lithium metal/alloy ...

USPS battery shipping allows you to ship it under certain conditions, but there are still some types of batteries that cannot be shipped. The following introduces nonmailable and mailable situations: USPS has strict rules for shipping batteries, and one of the most critical factors is Watt hours (Wh).

Except for mailpieces containing button cell batteries properly installed in the equipment they are intended to operate, mailpieces containing mailable lithium metal or lithium-ion batteries must be rigid, sealed, and of adequate size, so the lithium battery mark can be affixed to the address side without the mark being folded.

Definitions of lithium batteries. The term "lithium battery" or "lithium cell" refers to a family of batteries with different chemistries, comprising many types of cathodes and electrolytes. They are separated into: (I) Lithium ion batteries (Included lithium polymer batteries)

For shipping lithium batteries with USPS overseas, you can ship a maximum of 4 cells or 2 batteries that are installed in the new or certified refurbished equipment or device it operates, without any lithium battery markings. However, individual batteries are prohibited from USPS international shipping.

Improperly packaged lithium batteries can ignite, causing fires that are difficult to extinguish and pose a significant risk to the safety of transportation workers and the general public. ... Other batteries may be classified as restricted, which means there are specific rules about what types and how many you can send in a single shipment. ...

No - you are not able to send lithium batteries on their own through domestic or international post. UN 3481: Lithium ion batteries contained in equipment or lithium ion batteries packed with equipment. It is mandatory to identify the parcel with the lithium battery label. The label must be square. Minimum measuring requirements: 10 cm (height) x 10 ...

The outside of the package must be marked on the address side "Package Contains Lithium-ion Batteries (no lithium metal)." d. Mailed Without Equipment. The following additional restrictions apply to the mailing of secondary cells or batteries without equipment:

USPS has official instructions and guidelines for shipping batteries. ShipSaving helps you to highlight the following information: All packages containing lithium metal or lithium-ion batteries that can be mailed must be of sufficient size, sealed, and rigid. This ensures that the lithium battery mark can be affixed to the address without folding.
