USPS Packaging Instruction 9D Lithium Metal and Lithium-ion Cells and Batteries -- Domestic. Except according to 349.21, lithium metal (nonrechargeable) cells and batteries and lithium-ion (rechargeable) cells and batteries are mailable in limited quantities domestically via air or surface transportation when they are installed in or packed with the equipment they are intended to ...

When using an air transportation service like Priority Mail, you'll need the UN3481 Lithium Battery Handling Label. Sometimes, you may need to ship with a ground-based service, like when the lithium ion batteries are ...

You can mail a lithium battery-powered cellphone by the U.S. Postal Service in 2022, but you need to follow strict safety measures because these lithium batteries are highly flammable and will cause fires if not packaged right. ... Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations. In the United States, failure to comply with these regulations can result in a civil penalty of up to \$27,000 per offence (LBSR 1.3).

So, after having recently sold a couple things (some Samsung Galaxy Bluetooth Earbuds and a cell phone), I went to my local post office to ship the items, only to be told that they could not be shipped via Priority Mail, because of the Lithium batteries in the devices. Even with the items being brand new, still in the original packaging.

For instance, you can use air-based services (such as Priority Mail or UPS Next Day Air) to send electronics powered by lithium-ion batteries if--and only if--the item is brand-new and still contained in its

manufacturer's packaging. In the case of lithium-ion batteries, carriers prefer used electronics and electronics with opened ...

USPS has official instructions and guidelines for shipping batteries. ShipSaving helps you to highlight the following information: All packages containing lithium metal or lithium-ion batteries that can be mailed must be of sufficient size, sealed, and rigid. This ensures that the lithium battery mark can be affixed to the address without folding.

You mail all items at your own risk. Among other exceptions and limitations that may apply, we make no coverage for damages available for shipments containing electronic goods that you ship in any packaging other than: The manufacturer's original packaging, undamaged and retaining its intended shape and strength

Lithium batteries that power up scooters, hoover boards, electric skateboards, and e-bikes exceeding 100 Wh (Watt hours) cannot be shipped. Devices such as cellphones, watches, and vape with a single cell over 20Wh ...

As a result, you'll face more restrictions when it comes to sending them...especially for international shipments. Technically, you can ship lithium ion batteries internationally if they are pre-installed in the equipment they power. Lithium ion batteries are pre-installed inside of video game controllers, so you're good here. However, some ...

One thing to keep in mind is that cell phones contain lithium-ion batteries, and you need to affix the proper markings to your box in order to send them properly. ... and shippers can only send their packages via ground service. Each lithium-ion or lithium polymer cell or battery must not exceed a watt-hour rating of 2.7 Wh. Note: Shipments containing lithium batteries are not permitted in Global Express Guaranteed ...

USPS Standards for Domestic Shipments Containing Lithium Batteries. Each cell cannot contain more than 1 gram of lithium; Each battery cannot contain more than 2 grams of lithium; All packages must contain a complete return address; For non-installed batteries, your package must have a DOT-approved lithium battery mark (UN3090)

containing lithium batteries are prohibited and may not be mailed internationally or to, from or between APO, FPO, or DPO locations under any circumstances.

Persons wishing to ship lithium batteries and electronic devices containing lithium batteries should be aware that certain requirements must be met to ensure safety. PHMSA ...

Under federal law, it is illegal to send these types of ammunition, domestically or internationally, via the U.S. Mail. Small arms ammunition poses a significant danger to Postal employees, equipment, and customers, and you could be subject to civil penalties and criminal charges, if you send them through USPS.

This includes alkaline batteries, nickel-cadmium batteries, nickel-metal-hydride batteries, and lithium-ion batteries. However, there are some restrictions. You cannot mail button or coin cell batteries, such as those used in watches and hearing aids.

Quantity limits: Packages cannot contain more than 4 lithium metal cells or 2 lithium metal batteries, and cells can't exceed 1 gram of lithium content while batteries can't exceed 2 grams. For lithium-ion, packages are limited to 4 cells or 2 batteries with a maximum of 20 Wh per cell and 100 Wh per battery.

Sending lithium batteries through the mail can sometimes be difficult, because you don't know what you can or cannot ship through the mail. Multiple cell batteries inside the housing or casing exceeding 100Wh for each battery are nonmailable. Damaged/recalled individual batteries are prohibited and need approval. Domestic shipping via air: Maximum 8 cells or 2 batteries with or installed in the new or Manufacturer Certified Refurbished (MCR) equipment in the same package.

If you need to ship products such as laptops, tablets, mobile phones, or other products that use lithium batteries (either lithium-ion batteries or lithium metal batteries), you'll need to make sure your shipments meet shipping lithium battery requirements.

The Postal Service allows limited quantities of lithium batteries to be mailed domestically (within the U.S.) as long as certain conditions are met. Here are the key rules and ...
