Note 4: Lithium batteries packed according to PI965 Section IA and PI966 / PI967 Section I are not accepted in Time Definite International when transported via road to/from an ADR member state. Where packages of Section II lithium batteries from multiple packing instructions are included on one air waybill, the compliance statement for the different lithium battery types or packing instructions may be combined into a single statement, e.g. Lithium ion and metal batteries in compliance with Section II of PI 965 and 968 -- CAO.

What is--or was--Section II? Packing Instructions PI 965 and PI 968 govern standalone lithium batteries. Section II of these Packing Instructions was created to allow packages containing one or two small batteries to be shipped in the same package by air with fewer restrictions, and by people without extensive Dangerous Goods training.. Specifically, ...

UN3481, Lithium Ion Batteries / Cells - PI967 Section II (continuation). Shipper's Declaration is not required. The following statement must be mentioned on the (air)waybill: - "Lithium ion batteries in compliance with Section II of PI967". installed in equipment (including circuit boards).
