2024 has proven to be a tough year for large solar companies. If you've been following the news, you've probably noticed that the list of solar companies going out of business seems to keep getting longer. A confluence of factors, like higher interest rates and energy policy changes at the state level, have left some solar companies struggling to stay in business.

The solar company also owes \$2,000 to the Detroit Athletic Club. The only secured creditor in the case is JPMorgan Chase with a claim of \$80.6 million. Power Home Solar had a bright start. Founded by Waller, it began installing solar panels on houses in Michigan in 2017 and grew rapidly to around \$350 million in annual revenue as of 2020.
