In December 2013, the FCC issued regulation FCC 13--158 "Improving 911 Reliability" requiring Service Providers to meet specific performance standards for their E911/PSAP central office ...

In December 2003, the FCC began collecting data to build a registry of public safety answering points (PSAPs). A primary PSAP is defined as a PSAP to which 9-1-1 calls are routed directly from the 9-1-1 Control Office, such as, a selective router or 9-1-1 tandem. A secondary PSAP is defined as a PSAP to which 9-1-1 calls are transferred from a primary PSAP.

**Legacy PSAP Gateway** The LPG performs a similar function to the LNG, in that the LPG converts between IP and non-IP protocols used by legacy PSAPs. The LPG is a signaling (call setup) and media (for example, voice, video, text) interconnection point between the ESInet and the legacy PSAP.
