A no soliciting sign indicates that door-to-door sales and promotions are prohibited on a property. It communicates that solicitations are not welcome. A no soliciting sign template provides a standardized design.. The sign features clear text such as "No Soliciting" or "No Solicitors".Some versions also incorporate explanatory details of which activities are restricted.

As such, the new law alters who is allowed to perform solar sales. It provides that every Nevada "solar installation company" must hold a contractor's license under NRS Chapter 624, and that anyone providing a proposal or executing a contract for solar must hold licensed contractor.
