These scams start with an unexpected phone call, message on social, or even an in-person visit. The so-called official offers you an "energy audit" to reduce your utility costs. Or they might try to sign you up for a "free" program to make your ...

Did a salesperson knock on your door and promise free rooftop solar panels at no cost to you? While there are some government-funded solar programs for households that qualify, "going solar" isn't free. Honest ...

The only problem is that some solar companies use the wrong estimates for annual electricity price increases. Solar quotes almost always come with projected savings over 25 to 30 years. If a solar installer estimates an annual increase of more than 3% per year, they better have some very good data to back that up.

Legitimate companies will usually share the benefits of going solar (of which there are many!) without promising specific, guaranteed amounts. However, rebates and referral bonuses are common and legitimate ways solar installers ...

Know that "free" or "no cost" solar panel offers are scams. The federal government does not install solar systems in homes for free. The Attorney General's Office and the Department of Consumer Protection have received complaints of high-pressure sales tactics by solar companies. Even if a salesperson suggests you sign to "get the process going" or to "get more information," do not sign unless you are fully comfortable committing to the solar transaction.

To file complaints against solar panel companies, report fraud or scams in your state or locality to the DOJ. Begin your report by visiting your state's DOJ website. 4. Legal Assistance. If you've been scammed, seek legal advice. You may consider filing a case against the fraudulent company.

Solar panel fraud doesn't stop with the companies directly involved; lenders also find themselves liable. Sunlight Financial, Vision Solar's lender, recently declared bankruptcy, leaving consumers in a precarious situation. Solar panel systems are expensive, averaging \$18,355-36,277*. The larger and more powerful the system, the bigger the price tag. However, many solar companies offer financing options to help mitigate the monetary impact and spread the cost over time. Many states offer solar incentives as well.
