



# Solar energy charities

Thanks to the new direct pay provision available through the Inflation Reduction Act, nonprofits receive 30% or more in cash back on the cost of a solar system, making a compelling case to go solar. How can we ensure that communities nationwide know about and can take advantage of this opportunity?

In our 6-year history, we have completed solar energy systems that power food production, clean water through desalination, electricity in schools, businesses and emergency services, as well as animal and land conservation efforts.

The Basics of the Federal Solar Tax Credit. The Solar Investment Tax Credit (ITC) is a federal incentive that allows a significant deduction on the installation costs of solar energy systems. In 2024, this credit stands at 30% of the total cost of solar installation, covering a range of expenses from equipment to labor.

The U.S. Department of Energy (DOE) launched the \$50 million Renew America's Nonprofits Program - referred to in President Biden's Bipartisan Infrastructure Law as the Energy Efficiency Materials Pilot Program - to reduce carbon emissions, improve health and safety, and lower utilities costs at buildings owned and operated by 501(c)(3) nonprofits.

Bonus Adders: Nonprofits may be eligible for additional financial incentives known as bonus adders. These adders provide extra financial benefits on top of the standard tax credit, making solar projects even more

cost-effective. One type of bonus adder is the "low-income communities bonus adder".

In a significant stride towards sustainability, charities can now embrace solar panels with a 0% VAT relief, effective until March 31, 2027. This favourable development also extends to solar battery systems, presenting an opportune time for charitable organisations to harness renewable energy and reduce costs.
