For example, New York State also offers a 25% tax credit which can be used in addition to the 30% federal solar tax credit.

The eligibility criteria for solar panel grants differ significantly depending on the specific program. For instance, in order to qualify, you might need to reside in a specific area or type of property, meet certain income or financial criteria, or live in a building with a low energy efficiency rating.

For example, if your solar PV system was installed in 2022, installation costs totaled \$18,000, and your state government gave you a one-time rebate of \$1,000 for installing the system, your federal tax credit would be calculated as follows:  $\$18,000 * 0.30 = \$5,400$

The solar panel tax credit allows filers to take a tax credit equal to up to 30% of eligible costs. There is no income limit to qualify, and you can claim the credit each year you're eligible for it. The credit amount will remain 30% through 2032.

A tax credit is a dollar-for-dollar reduction of your tax bill that you can claim when filing your annual taxes. The solar tax credit is nonrefundable, so you won't receive a separate check for that 30% savings, but it will lessen what you owe in taxes, which means you ultimately get a bigger tax refund. For example, if you owe \$9,000 in taxes for 2023, and you can claim a ...

When this is the case, the utility rebate for installing solar is subtracted from your system costs before you calculate your tax credit. There are currently three government grants available to help with the upfront costs of solar panel installation: ECO4: Funding for energy-efficient retrofits to fuel-poor households, or ones with occupants on certain benefits. Each grant has different eligibility criteria, as well as the benefits they provide.
