Florida State Solar Overview. Florida's solar policies have lagged behind other states: it has no renewable portfolio standard and does not allow power purchase agreements, two policies that have driven investments in solar in other states. However, due to utility investments in clean energy and other recent developments, significant growth is on the horizon.

For now, rooftop solar companies in Florida look for ways to operate in Florida despite the laws that restrict the industry. With third-party sales outlawed, companies instead offer financing for solar power, said Scott McIntyre, CEO of solar panel installer Solar Energy Management in Tampa.

Off-grid electricity systems, including solar and wind power, are legal in Florida. There are no laws preventing you from disconnecting from the power company and creating your own "microgrid." In almost all cases, you must get a permit for your system.
