Another type of IPO includes the traditional IPO with early releases. This means your company allows you to sell a certain percentage of your vested equity at specific times during the lock-up period. For example, if your company had its IPO today, your company may allow you to sell up to 25% of your vested equity in the first two weeks from today.
